WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0499 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL HEALTH OFFICE in undertaking Procurement Request under PR No. 2022-C-131 re: PROCUREMENT OF MEALS AND SNACKS FOR THE ADOLESCENT YOUTH DEVELOPMENT PROGRAM with an ABC of P 203, 900.00;

WHEREAS, canvass of prices done in the course of the **Negotiated Method** of showed that <u>REYNA'S THE HAVEN</u>
