WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY. of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 101 re: PROCUREMENT OF AUTOCLAVE SINGLE CHANNEL PIPETTORS & 96 WELLS PCR PLASTIC RACK with an ABC of P 117,300.00.
