



**BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD**

**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0810 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL ENGINEERING OFFICE** in undertaking Procurement Request under PR No. 2022-0392; Procurement of of various Spare Parts, oil and lubricants for the Repair/Replacement parts, etc.. for Mitsubishi Strada, SKN - 840, by the Provincial Engineering Office (PEO), with an ABC of ₱ 137,565.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

**WHEREAS**, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** has been found to be ELIGIBLE and its quotation, RESPONSIVE;

- b). To recommend award to **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** or delivery of goods/services under Negotiated Canvass No. 2022-0345 (2nd Failure) in the amount of ₱ 137,493.00;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
