**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022 – 0452** re; **Procurement of various Oil and Lubricants** with an ABC of **P 330,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **JETS MARKETING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
