**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0109-A Series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT in undertaking Procurement Request under PR No. 2022-0053, Procurement of Desktop Computer & Printer, the Office of the Provincial Social Welfare & Development, Tamblot Street, Tagbilaran City, Bohol, with an ABC of ₱ 228,500.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC., offered the lowest price quotation among the suppliers as reflected in Abstract of Bid Quotation;




**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:



- To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




