BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0628 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE** in undertaking Procurement Request under PR No. 2022-0279; Procurement of Digital Voice Recorder, Micro USB with OTG & External Hard Drive, by the Bohol Provincial Environment Management Office, New Capitol Building, Tagbilaran City, with an ABC of ₱ 28,930.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




