**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0152-A Series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT**, in undertaking Procurement Request under PR No. **2022-0076**; Procurement of Desktop, Laptop & Printer, by the Office of the Provincial Social Welfare & Development, Tamblot Street, Tagbilaran City, Bohol. with an ABC of **₱ 277,760.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:




