WHEREAS, the **GOVERNOR'S OFFICE – BFP/ PIFARERDS** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-451** re: **PROCUREMENT OF ACCOMMODATION AND CATERING SERVICES FOR THE FIFTEEN (15) DAYS BASIC RESCUE TECHNIQUE COURSE (BRTC) TRAINING** with an ABC of **₱ 390,000.00**;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:




