BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF BOARD MEMBER GREG CRISPINITO JALA, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022 - 0619** re: **Purchase of Tires, Battery, Spare Parts, Oil and Lubricants** with an ABC of **P 204,382.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **NORTHWAY TYRE CENTRE**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
