**BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD**

**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1584 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL TOURISM OFFICE, OLD CAPITOL BUILDING, TAGBILARAN CITY** in undertaking Procurement Request under PR No. **2022-0565** re; Procurement of Tourism Tour Handlers Services with an ABC of **P200,000.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **RAMYER TRAVEL & TOUR**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

**WHEREAS**, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **RAMYER TRAVEL & TOUR** has been found to be **ELIGIBLE** and its quotation, **RESPONSIVE**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:
