**CONTRACT AGREEMENT**

THIS AGREEMENT made between the **Provincial Government of Bohol**, Capitol Compound, Tagbilaran City (hereinafter called “**the Entity**”) of the one part and **RAMYER TRAVEL & TOUR**, 0364 N24 Building (Bernaldez), cor. B. Aquino & Lamdagan St., Cogon District, Tagbilaran City (hereinafter called “**the Supplier**”) of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services viz., for the **Procurement of Tourism Tour Handlers Services for PROVINCIAL TOURISM OFFICE, OLD CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, BOHOL** and has accepted a quotation by the supplier for the services in the sum of **One Hundred Ninety Seven Thousand Three Hundred Ninety Two Pesos Only (P 197,392.00)** hereinafter called “**the Contract Price**”.

The Entity hereby covenants to pay the Supplier in consideration of the provisions of the goods and services and the remedying of defects therein, the Contract price of such other sum as may become payable under the provision of the Contract at the time and in the manner prescribed by the contract.
