BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE GOVERNOR – OFFICE OF GOVERNANCE ACCOUNTABILITY AND REVIEW, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 – 0672 re; Purchase of CURTAINS AND WATER DISPENSER with an ABC of P 109,730.80;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of PRIM E CONSTRUCTION SUPPLIES TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation PRIM E CONSTRUCTION SUPPLIES TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare PRIM E CONSTRUCTION SUPPLIES TRADING as the supplier with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2022 – 0479;
- b.) To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING for the delivery of goods/services under Negotiated Canvass No. 2022 – 0479 in the amount of P 109,696.50;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
