WHEREAS, the **PROVINCIAL INFORMATION AND MEDIA OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of the goods under Purchase Request No. **2022-0612** re: Procurement of Ink for High Speed Inkjet Printer with an ABC of **P 511,992.00**


WHEREAS, the above Procurement Request was presented to the **BIDS AND AWARDS COMMITTEE** for deliberation and proper action;




