**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **OFFICE OF THE GOVERNOR – PUBLIC SAFETY, SECURITY AND ORDER, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022 – 0675** re; **Purchase of DESKTOP COMPUTER** with an ABC of **P 223,505.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **PRIM E CONSTRUCTION SUPPLIES TRADING**, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **PRIM E CONSTRUCTION SUPPLIES TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **PRIM E CONSTRUCTION SUPPLIES TRADING** as the supplier with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. **2022 – 0482**;
- b.) To recommend award to **PRIM E CONSTRUCTION SUPPLIES TRADING** for the delivery of goods/services under Negotiated Canvass No. **2022 – 0482** in the amount of **P 223,490.00**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
