BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the CANDIJAY COMMUNITY HOSPITAL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0020 re: REPAIR OF WATER SUPPLY SYSTEM CANDIJAY COMMUNITY HOSPITAL, CANDIJAY, BOHOL with an ABC of ₱ 101,208.91;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that C. JANSEN CONSTRUCTION & GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
