BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0021 re; REPAIR OF PCR LABORATORY, DIALYSIS CENTER AND SURGICAL WARD AT THE GARCIA MEMORIAL PROVINCIAL HOSPITAL, SAN JOSE, TALIBON, BOHOL with an ABC of ₱ 276,291.67;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that C. JANSEN CONSTRUCTION & GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




