BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the **OFFICE OF THE PROVINCIAL AGRICULTURIST** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. 2022-C-380 re: **PROCUREMENT OF FULLBOARD ACCOMMODATION FOR THE PARTICIPANTS OF THE PDRRM-H IN EMERGENCY AND INFORMATION MANAGEMENT TRAINING** with an ABC of **₱810,800.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that **BEST WESTERN PLUS THE IVYWALL RESORT PANGLAO/ IWH BOHOL RESORT CORP.** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
