BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1747 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **OFFICE OF THE PROVINCIAL AGRICULTURIST, NEW CAPITOL BUILDING, TAGBILARAN CITY** in undertaking Procurement Request under PR No. 2022-0388 re; Procurement of Desktop Computer, Printers, Internet Cable Wire (CAT6), Mobile Cellular Phone and Router with an ABC of **P 250,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **B & J COMPUTER SALES AND ELECTRONIC SERVICES INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **B & J COMPUTER SALES AND ELECTRONIC SERVICES INC.** has been found to be ELIGIBLE and its quotation, RESPONSIVE;
