BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL BUDGET AND MANAGEMENT OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0615, re; Procurement Laptop and CPU/ Monitor for use at the Provincial Budget and Management Office, New Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 140,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **SANDUGO PRESS MARKETING AND SUPPLIES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
