BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE** of the **PROVINCIAL GOVERNMENT BOHOL** made procurement under Purchase Request No. **2022-C-287** re: **PROCUREMENT OF MEALS AND SNACKS FOR 1 GOVERNOR, MAYORS AND PARTICIPANTS OF THE INCIDENT COMMAND SYSTEM (ICS) EXECUTIVE COURSE FOR LOCAL CHIEFS OF EXECUTIVES AND KEY STAFF FOR MAYORS, SECRETARIAT, SUPPORT STAFF FOR INCIDENT COMMAND SYSTEM (ICS) EXECUTIVE COURSE** with an ABC of **₱ 174,000.00**;

- b). To recommend award to **THE METROCENTRE HOTEL** for the Catering Services of the aforementioned request in the amount of **₱ 174,000.00**;
