**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2022 - 0607**, re; **Procurement of Tubeless Tires, Oil Filters, and Diesel Engine Oils** with an ABC of **P 446,600.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **NORTHWAY TYRE CENTRE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
