BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of</u> the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022 – 0607</u> re; <u>Procurement of Tubeless Tires</u>, Oil Filters, and Diesel Engine Oils with an ABC of P <u>446,600.00</u>;
