WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022-0616** re; **Procurement of DIESEL ENGINE OIL**, with an ABC of **P 103,200.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **JETS MARKETING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
