
**NOW THEREFORE**, We the Members of the Bids and Awards Committee, hereby **RESOLVED**:

- a.) To declare **RGZI MEDICAL AND LABORATORY SUPPLY** as the **LOWEST CALCULATED AND RESPONSIVE BID** for item no. 1 in the amount of **P 53,375.00**, and **JN'J PHARMA & MEDICAL SUPPLIES** as the **LOWEST CALCULATED AND RESPONSIVE BID** for item no. 2 in the amount of **P 77,125.00** under Project Reference No. - PHO - 2022-088.



- b.) To recommend award to **RGZI MEDICAL AND LABORATORY SUPPLY** in the contract amount of **FIFTY THREE THOUSAND THREE HUNDRED SEVENTY FIVE PESOS ONLY (P 53,375.00)**, and **JN'J PHARMA & MEDICAL SUPPLIES** in the contract amount of **SEVENTY SEVEN THOUSAND FIVE HUNDRED SEVENTY FIVE PESOS ONLY (P 77,575.00)**;
- c.) To recommend for the approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




