**BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award**

**WHEREAS**, the **PROVINCIAL HEALTH OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-437** re: **PROCUREMENT OF VENUE, ACCOMMODATION, MEALS AND SNACKS FOR THE PHO STRATEGIC PLANNING** with an ABC of **₱280,000.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that **BEST WESTERN PLUS THE IVYWALL RESORT PANGLAO/ IWH BOHOL RESORT CORP.** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
