BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the <u>CLARIN COMMUNITY HOSPITAL</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-294 re: <u>PROCUREMENT OF ACCOMMODATION. MEALS AND SNACKS FOR THE CLACH MID-YEAR ASSESSMENT 2022</u> with an ABC of <u>P 99,981.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BEST WESTERN PLUS</u> <u>THE IVYWALL RESORT PANGLAO</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BEST WESTERN PLUS THE IVYWALL RESORT PANGLAO</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>BEST WESTERN PLUS THE IVYWALL RESORT PANGLAO</u> has been found to be <u>ELIGIBLE</u> and its bid, <u>RESPONSIVE</u>;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare <u>BEST WESTERN PLUS THE IVYWALL RESORT PANGLAO</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE QUOTATION</u> for the <u>CATERING SERVICES</u> under Negotiated Canvass No. <u>2022-279</u>;
- To recommend award to <u>BEST WESTERN PLUS THE IVYWALL RESORT PANGLAO</u> for the Catering and Accommodation Services of the aforementioned request in the amount of <u>P 99,981.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
