BAC RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING APPROVAL

WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. **2022-219** series of 2018 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL** in undertaking Procurement Request under **PR No. – PHO – 2022 – 049** re: **Procurement of Medical Supplies** with an ABC of **P 810,300.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **N&M MEDICAL SUPPLY** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **N&M MEDICAL SUPPLY** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a. To declare **N&M MEDICAL SUPPLY** as the supplier with the Lowest and Responsive Price Quotation of items no. 2, 3, 7, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 20, 21, 22, 23, 25, 26, 27, 29, 31, 35, 36, 37, 38, 39, 43, 44, 45, 46, 47, 51, 52 & 53 for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2022 – 053 (2nd Failure of Bidding)**. While items no. 1, 4, 5, 6, 8, 19, 24, 28, 30, 32, 33, 34, 40, 41, 42, 48, 49, 50, 54, 55 & 56 having no quotation from the supplier is recommended for re-canvass.
- b. To recommend award **N&M MEDICAL SUPPLY** for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2022 – 053 (2nd Failure of Bidding)**; in the amount of **P 537,389.00**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
