WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by PROVINCIAL LEGAL OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY in undertaking Procurement Request under PR No. 2022-0466 re; Procurement of Desktop Computer, Laptop, LCD Projector, Ultra High Performance Webcam, Headphone, Sound System with Wireless Mic & Eco Tank all-in-one Printer with an ABC of P325,414.00;
