WHEREAS, the PROVINCIAL MOTORPOOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-337 re: PROCUREMENT OF MEALS AND SNACKS FOR THE PMPO EMPLOYEES DURING THE FAMILY DAY 2022 with an ABC of P 72,200.00;
