BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the <u>PROVINCIAL YOUTH DEVELOPMENT OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-431 re: <u>PROCUREMENT OF MEALS AND SNACKS FOR THE SERIES OF TRAININGS OF THE BATANG PINOY ATHLETES</u> with an ABC of <u>P1,425,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that <u>PANDA TEA GARDEN SUITES</u> offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
