BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the CENTER FOR DRUG EDUCATION AND COUNSELLING of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-227 re: PROVISION OF MEALS INCLUDING SNACKS (AM/ PM) FOR THE CONDUCT OF UPDATE TRAINING FOR THE 48 LGU REPRESENTATIVES IN THE IMPLEMENTATION OF COMMUNITY REHABILITATION with an ABC of ₱ 150, 000.00;
