**BAC Resolution Declaring LCRQ and Recommending Award** 

WHEREAS, the <u>CENTER FOR DRUG EDUCATION AND COUNSELLING</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-227 re: <u>PROVISION OF MEALS INCLUDING SNACKS (AM/ PM)</u> FOR THE CONDUCT OF <u>UPDATE TRAINING FOR THE 48 LGU REPRESENTATIVES IN THE IMPLEMENTATION OF COMMUNITY REHABILITATION</u> with an ABC of <u>P 150, 000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>CASA REY FRANCIS PENSION HOUSE AND RESTAURANT</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
