WHEREAS, the GOVERNOR'S OFFICE – SPECIAL PROJECT SECTION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. **2022-C-162** re: PROCUREMENT OF MEALS AND ROOM ACCOMMODATION FOR THE DEVELOPMENTAL AND CONSULTATIVE MEETINGS INCLUDING COURTESY VISIT WITH VARIOUS STAKEHOLDERS, SECTORAL GROUPS AND PRIVATE SECTORS with an ABC of **₱ 305,000.00**;
