BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL COOPERATIVE DEVELOPMENT OFFICE of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-385** re: PROCUREMENT OF MEALS AND SNACKS FOR THE COMMUNITY ORGANIZING – COMMUNITY DEVELOPMENT TRAINING FOR PCDO FIELD WORKERS AND COMMUNITY ORGANIZERS with an ABC of **₱ 225,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
