BAC RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1386 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2022-0008 re: ESTABLISHMENT OF BANGUS FINGERLINGS PRODUCTION AND HOLDING AREA AT BISU CALAPE, BOHOL with an ABC of P3,515,622.44;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>THREE K</u>

CONSTRUCTION AND ENTERPRISES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under <u>paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, THREE K CONSTRUCTION AND ENTERPRISES, INC.</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare <u>THREE K CONSTRUCTION AND ENTERPRISES, INC.</u> as the supplier with the <u>Lowest and Responsive Price Quotation</u> for the Delivery of <u>Goods/Services</u> under Negotiated Canvass No. <u>NC-2022-0016(2<sup>nd</sup> Failure);</u>
- To recommend award to <u>THREE K CONSTRUCTION AND ENTERPRISES</u>, <u>INC.</u> for delivery of goods/services under Negotiated Camwass No. <u>NC-2022-0016(2<sup>nd</sup> Failure)</u> in the amnount of <u>P-3,508,279.18</u>;
- c) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
