**BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD**

**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-074-A series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL ENGINEER'S OFFICE** in undertaking Procurement Request under PR No. 2022-0222; Procurement of Diesel for Machine Patching nad Road Reshaping of Popoo-Tugas Aquining road and Barangay Roads, by the Provincial Engineering Office (PEO), with an ABC of ₱ 288,770.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL J DISTRIBUTION SYSTEM INC.**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
