**BAC RESOLUTION DECLARING LOWEST COMPLYING AND RESPONSIVE BID AND RECOMMENDING APPROVAL**

**WHEREAS**, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

**WHEREAS**, in the detailed evaluation of bids SANDUGO PRESS MARKETING AND SUPPLIES, was declared as the Lowest Calculated Bid as Read in the amount of **P 700,215.00.**, BOHOL QUALITY CORPORATION has the lowest Calculated Bid as Read in the amount of **P 668,047.25**.

**WHEREAS**, upon the conduct of post qualification by the Technical Working Group, SANDUGO PRESS MARKETING AND SUPPLIES & BOHOL QUALITY CORPORATION met the required legal, technical and financial requirements for the said project;

**WHEREAS**, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by SANDUGO PRESS MARKETING AND SUPPLIES & BOHOL QUALITY CORPORATION the bidder declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for the said project;

- a.) To declare SANDUGO PRESS MARKETING AND SUPPLIES as the **LOWEST CALCULATED and RESPONSIVE BID** for items no. 13, 19, 22, 24, 26, 27, 28, 31, 32, 33, 34, 38, 42, 43, 45, 46, 47 & 55 in the amount of **P 208,300.00**, BOHOL QUALITY CORPORATION, as the **LOWEST CALCULATED and RESPONSIVE BID** for items no. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 14, 15, 16, 17, 18, 20, 21, 25, 29, 30, 35, 36, 37, 39, 40, 41, 44, 48, 49, 50, 51, 53, 54, 56, 57, 58, 59 & 60 in the amount of **P 363,426.00** for the procurement of **VARIOUS OFFICE SUPPLIES** under Project Reference No.- **PHO - 2022 – 078**; while items no. 12, 23 & 52 the quotation from the supplier are above ABC recommended for rebidding.

To recommend award to SANDUGO PRESS MARKETING AND SUPPLIES in the contract amount of **TWO HUNDRED EIGHT THOUSAND THREE HUNDRED PESOS ONLY (P 208,300.00)** and BOHOL QUALITY CORPORATION in the contract amount of **THREE HUNDRED SIXTY THREE THOUSAND FOUR HUNDRED TWENTY SIX PESOS ONLY (P 363,426.00)**.
