BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL PLANNING & DEVELOPMENT OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0584, re: Provision for the Vehicle Rental, by the Provincial Planning & Development Office, New Capitol Building, Tagbilaran City, with an ABC of P 97,300.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL TOURIST MULTI-PURPOSE COOPERATIVE**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **BOHOL TOURIST MULTI-PURPOSE COOPERATIVE**, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **BOHOL TOURIST MULTI-PURPOSE COOPERATIVE** has been found to be ELIGIBLE and its bid, RESPONSIVE;
