**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021 - 0355 re; Purchase of MULTIPURPOSE RACK, WOODEN CABINET WITH SHELVES, STEEL CABINET, OFFICE TABLE WITH SIDE DRAWERS, SWIVEL CHAIR WITH ARMREST, TIFFANY CHAIRS, WINDOW BLINDS, NATIVE FOLDABLE PARTITION with an ABC of P 100,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of PRIM E CONSTRUCTION SUPPLIES TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation PRIM E CONSTRUCTION SUPPLIES TRADING, has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare PRIM E CONSTRUCTION SUPPLIES TRADING, as the supplier with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2021 - 0218;
- b.) To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING for the delivery of goods/services under Negotiated Canvass No. 2021 - 0218, in the amount of P 99,940.00;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
