WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0313-A series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2022-C-097 re: PROCUREMENT OF ACCOMMODATION, MEALS AND SNACKS FOR THE GEOPARK TECHNICAL EXPERTS/ ADVISERS, PERSONNEL AND PARTNERS (LOCAL/INTERNATIONAL) with an ABC of P 120, 000.00;

WHEREAS, canvass of prices done in the course of the **Negotiated Method** of showed that <u>REYNA'S THE HAVEN</u> <u>AND GARDENS FOOD CATERING SERVICES, INC.</u> offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
