**WHEREAS**, the CENTER FOR DRUG EDUCATION AND COUNSELLING of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-228** re: **PROVISION OF MEALS INCLUDING SNACKS (AM/ PM) FOR THE VALIDATION/ REVALIDATION OF DRUG-CLEARED BARANGAYS FOR 2 DAYS** with an ABC of **₱ 150, 000.00**;
