**BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the BOHOL DISTRICT JAIL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-466 re: PROCUREMENT OF CATERING SERVICES FOR THE BDJ YEAR-END ASSESSMENT with an ABC of P68,750.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
