WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No 21-1778 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY in undertaking Procurement Request under PR No. 2022-0438 re; Procurement of Four-Wheel-Drive Double Cab Pick-up type Vehicle (Brand new) with an ABC of P1,500,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that FAST AUTOWORLD PHILS. CORP, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
