BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1778, series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **OFFICE OF THE PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** in undertaking Procurement Request under PR No. 2022-0438 re: Procurement of Four-Wheel-Drive Double Cab Pick-up type Vehicle (Brand new) with an ABC of P 1,500,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **FAST AUTOWORLD PHILS. CORP.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
