BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF BOARD MEMBER TOMAS D. ABAPO, JR.**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022-0716** re; **Procurement of Philippines Flags and Bohol Flags** with an ABC of **P 88,500.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DELMA ENTERPRISE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **DELMA ENTERPRISE** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **DELMA ENTERPRISE** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;
