BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **GOVERNOR'S OFFICE - CCAD** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-428** re: **PROCUREMENT OF MEALS FOR THE WORKING PERSONNEL, PERFORMERS, JUDGES AND GUESTS DURING THE LAUNCHING AND COMPETITION OF KASADYA, PASKO SA BOHOL** with an ABC of **₱165,750.00**;






