BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-443 re: PROCUREMENT OF MEALS AND SNACKS DURING THE INTER-AGENCY COORDINATION/ CONVERGENCE MEETING WITH LGUS, NGAS WITH PROVINCIAL OFFICES AND OTHER GOVERNMENT AGENCIES with an ABC of P612,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
