BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-443 re: PROCUREMENT OF MEALS AND SNACKS DURING THE INTER-AGENCY COORDINATION/CONVERGENCE MEETING WITH LGUS, NGAS WITH PROVINCIAL OFFICES AND OTHER GOVERNMENT AGENCIES with an ABC of P612,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA GARDEN</u> <u>SUITES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
