**BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the **GOVERNOR'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-478** re: **PROCUREMENT OF MEALS, SNACKS AND USE OF FACILITY FOR THE BOHOL CIVIL SOCIETY ORGANIZATION'S WEEK: CSO OPENING PROGRAM** with an ABC of **P260,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
