BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-479re: PROCUREMENT OF MEALS, SNACKS AND USE OF FACILITY FOR THE BOHOL CIVIL SOCIETY ORGANIZATION'S WEEK: CSO TEAM BUILDING AND FELLOWSHIP with an ABC of ₱180,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL BEE FARM RESORT AND FRANCHISING CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
